

## THE FARM & RANCH STRESS ASSISTANCE NETWORK

The Farm and Ranch Stress Assistance Network (FRSAN) was authorized by Congress in the 2008 Farm Bill. This program, if funded, will provide behavioral health supports for stressed farmers in many areas of the country. These supports include telephone hotlines that are geared to the farm population, follow-up behavioral health counseling, support groups, home visitation services and others.

The FRSAN has gained popular support over the last couple years. There are currently 38 states that have expressed an interest in starting a FRSAN-type program. There are also 14 major organizations representing more than 1 million constituents that have confirmed their support for the FRSAN.

Even though Congress authorized the FRSAN, it has yet to approve funding for it. There are currently several efforts underway in Congress to seek funds for the program for fiscal year 2011.

Supporters of FRSAN have requested official letters of support from Senator Pat Roberts and Senator Sam Brownback of Kansas. Senator Tom Harkin (IA) is carrying an official letter of support to the Senate Subcommittee on Agriculture, Rural Development, Food and Drug Administration, and Related Agencies and to the Subcommittee on Labor, Health and Human Services, Education, and Related Agencies.

Senator Kirsten Gillibrand (NY) has written a letter requesting passage of appropriations to fund the FRSAN.

Senators Charles Grassley (IA) and Tim Johnson (SD) have written a letter together requesting passage of appropriations for the program.

An appropriations request was also sent to Senator Herb Kohl (WI) and Representative David Obey (WI).
